Carolina maintenance customer: Includes inspections only. Filters and cleaning of coils (if cleaner is needed) is not included. All major parts and Freon are not included and will be charged accordingly. The price of this option is \$155.00 for the first system and \$115.00 each additional system both options include 2 annual inspections. Payment must be paid in full on or before the first scheduled PM appointment. This agreement is non-refundable.

Carolina maintenance customers will receive a 15% discount on repairs between services; also priority service if a breakdown occurs. The 15% discount does not apply to new installations of new systems.

Filter replacement is still required to be done between intervals and is the customer's responsibility to provide and replace filters when needed.

Humidifiers are an additional \$53.00 per year, which includes the water panel or water filter. Space-guard media type filters are \$40.00 per media replacement.

Add \$10.00 to each roof top unit.

This maintenance contract does not apply to oil fired equipment and boilers.
